Keep Food Containers Safe from PFAS Act of 2021

This bill prohibits food packaging that contains intentionally added PFAS (i.e., a perfluoroalkyl substance or a polyfluoroalkyl substance that is man-made with at least one fully fluorinated carbon atom).

Actions Timeline

- **Nov 18, 2021:** Referred to the House Committee on Energy and Commerce.
