Summary (as of Nov 18, 2021)

Aviation Noise and Emissions Mitigation Act

This bill requires the Environmental Protection Agency to establish pilot grant programs to measure and mitigate aircraft and airport noise and emissions (e.g., greenhouse gases and toxic pollutants) in communities near airports and air flight pathways.

Actions Timeline

- **Nov 19, 2021:** Referred to the Subcommittee on Environment and Climate Change.
- **Nov 19, 2021:** Referred to the Subcommittee on Aviation.
- **Nov 18, 2021:** Introduced in House
- **Nov 18, 2021:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Transportation and Infrastructure, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
