Condemning the Biden administration's Executive actions imposing a moratorium on oil and gas leases on Federal lands and waters, given the administration has also called for increased importation of crude oil from OPEC+ countries and refused to implement congressionally mandated sanctions on the builders of the Russian Nord Stream 2 pipeline.
