### Summary (as of Dec 7, 2021)

#### Opioid Quota Openness, Transparency, and Awareness Act of 2021 or the Opioid QuOTA Act of 2021

This bill requires the Drug Enforcement Administration to make publicly available on its website certain information regarding opioid procurement quotas.

The term *opioid procurement quota* means the maximum quantity of opioid analgesics that a registered manufacturer may procure.

- **Nov 1, 2022:** Referred to the Subcommittee on Crime, Terrorism, and Homeland Security.
- **Dec 8, 2021:** Referred to the Subcommittee on Health.
- **Dec 7, 2021:** Introduced in House
- **Dec 7, 2021:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on the Judiciary, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
