Summary (as of Dec 8, 2021)

Protecting International Pipelines for Energy Security Act

This bill requires the President to obtain the approval of Congress before revoking a permit or other authorization required under executive orders for constructing, connecting, operating, or maintaining an oil or natural gas pipeline, an electric transmission facility, or a border-crossing facility.

Actions Timeline

- **Dec 17, 2021:** Referred to the Subcommittee on Energy and Mineral Resources.
- **Dec 9, 2021:** Referred to the Subcommittee on Energy.
- **Dec 9, 2021:** Referred to the Subcommittee on Railroads, Pipelines, and Hazardous Materials.
- **Dec 8, 2021:** Introduced in House
- **Dec 8, 2021:** Referred to the Committee on Transportation and Infrastructure, and in addition to the Committees on Energy and Commerce, and Natural Resources, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
