## **Taiwan Preclearance Act**

This bill requires the Department of Homeland Security to report to Congress on various issues, including (1) a plan for establishing a U.S. Customs and Border Protection preclearance facility in the Indo-Pacific region; (2) an analysis of the feasibility and advisability of establishing a preclearance facility in Taiwan; and (3) an assessment of the impact that a preclearance facility will have on trade, tourism, and the security partnership between Taiwan and the United States.

(Preliminary facilities are stations in designated foreign airports that inspect travelers prior to boarding U.S.-bound flights.)

## **Actions Timeline**

---

- **Dec 10, 2021:** Referred to the Subcommittee on Border Security, Facilitation, and Operations.
- **Dec 9, 2021:** Introduced in House
- **Dec 9, 2021:** Referred to the Committee on Homeland Security, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
