Summary (as of Sep 22, 2022)

Invest to Protect Act of 2022

This bill directs the Office of Community Oriented Policing Services within the Department of Justice to award grants to local and tribal governments that employ fewer than 125 law enforcement officers. Grant funds may be used for various activities, including to provide de-escalation training and improve recruitment and retention.

Actions Timeline

- **Sep 27, 2022:** Received in the Senate.
- **Sep 22, 2022:** Considered under the provisions of rule H. Res. 1377. (consideration: CR H8085-8090)
- **Sep 22, 2022:** Rule provides for consideration of H.R. 4118, H.R. 5768, H.R. 6448 and H.R. 8542. Resolution provides for 30 minutes of general debate with one motion to recommit for each bill.
- **Sep 22, 2022:** DEBATE - The House proceeded with 30 minutes of debate on H.R. 6448.
- **Sep 22, 2022:** The previous question was ordered pursuant to the rule.
- **Sep 22, 2022:** POSTPONED PROCEEDINGS - At the conclusion of debate on H.R. 6448, the Chair put the question on passage of the bill and by voice vote, announced that the ayes had prevailed. Mr. Jordan demanded the yeas and nays and the Chair postponed further proceedings until a time to be announced.
