Access to AEDs Act

This bill requires the Department of Health and Human Services to award grants to local educational agencies and private elementary and secondary schools, in partnership with a health care entity, to promote student access to defibrillation in elementary and secondary schools.

Actions Timeline

- **Jan 31, 2022:** Referred to the Subcommittee on Health.
- **Jan 28, 2022:** Introduced in House
- **Jan 28, 2022:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Education and Labor, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
