Actions Timeline

- **Sep 21, 2021:** Introduced in House
- **Sep 21, 2021:** The House Committee on Rules reported an original measure, H. Rept. 117-125, by Ms. Ross.
- **Sep 21, 2021:** Rule provides for one hour of debate on H.R. 3755; one hour of debate on H.R. 4350, with consideration under a structured rule; and one hour of debate on H.R. 5305, with consideration under a closed rule. The rule provides that proceedings may be postponed through October 1, 2021, on measures that were the object of motions to suspend the rules on the legislative days of July 26, July 27, or September 21, 2021 and on which the yeas and nays were ordered. The rule provides that House Resolution 188, agreed to March 8, 2021, is further amended by striking "September 22, 2021" and inserting "October 27, 2021".
- **Sep 21, 2021:** Placed on the House Calendar, Calendar No. 34.
- **Sep 21, 2021:** Considered as privileged matter. (consideration: CR H4564-4576)
- **Sep 21, 2021:** DEBATE - The House proceeded with one hour of debate on H. Res. 667.
- **Sep 21, 2021:** On ordering the previous question Agreed to by the Yeas and Nays: 218 - 210 (Roll no. 263).
- **Sep 21, 2021:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 217 - 207 (Roll no. 264). (text: CR H4564-4565)
