## Summary (as of Sep 23, 2021)

This resolution urges the Biden Administration to expeditiously restore the Migrant Protection Protocols, a policy requiring many asylum seekers arriving at the southern border to wait in Mexico while their cases are being adjudicated. It also urges the Administration to use certain public health powers, commonly referred to as *Title 42* authority, to promptly expel migrants.

## Actions Timeline

- **Nov 1, 2022:** Referred to the Subcommittee on Immigration and Citizenship.
- **Sep 24, 2021:** Referred to the Subcommittee on Health.
- **Sep 24, 2021:** Referred to the Subcommittee on Border Security, Facilitation, and Operations.
- **Sep 23, 2021:** Introduced in House
- **Sep 23, 2021:** Referred to the Committee on the Judiciary, and in addition to the Committees on Homeland Security, Energy and Commerce, and Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Sep 23, 2021:** Referred to the Subcommittee on Trade.
