### No Pro-Abortion Task Force Act

This bill prohibits federal funding of the Reproductive Healthcare Access Task Force.

The Department of Health and Human Services launched the task force on January 21, 2022, to identify and coordinate departmental activities related to accessing sexual and reproductive health care.
