Ending Dependence on Russian Energy Act

This bill addresses the production of oil and gas, the importation of oil or natural gas from Russia, and the exportation of oil or natural gas to other countries.

Specifically, the bill approves the TransCanada Keystone Pipeline in Phillips County, Montana for the import of oil from Canada to the United States.

In addition, the bill requires the President to (1) prohibit the importation of oil or natural gas originating from Russia, and (2) seek to reduce restrictions on the exportation of oil or natural gas originating from the United States.

Actions Timeline

- **Mar 8, 2022:** Referred to the Subcommittee on Energy and Mineral Resources.
- **Mar 4, 2022:** Referred to the Subcommittee on Energy.
- **Mar 4, 2022:** Referred to the Subcommittee on Railroads, Pipelines, and Hazardous Materials.
- **Mar 3, 2022:** Introduced in House
- **Mar 3, 2022:** Referred to the Committee on Ways and Means, and in addition to the Committees on Transportation and Infrastructure, Energy and Commerce, Natural Resources, and Foreign Affairs, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
