## Summary (as of Apr 6, 2022)

### Victims of Child Abuse Act Reauthorization Act of 2022

This bill reauthorizes for FY2022-FY2028 and otherwise revises grants for local and regional children's advocacy centers (CACs). CACs coordinate a multidisciplinary response to child abuse.

### Actions Timeline

- **Nov 1, 2022:** Referred to the Subcommittee on Crime, Terrorism, and Homeland Security.
- **Apr 6, 2022:** Introduced in House
- **Apr 6, 2022:** Referred to the Committee on the Judiciary, and in addition to the Committee on Education and Labor, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
