21st Century Courts Act of 2022

This bill provides for the establishment of a code of conduct for Supreme Court Justices, judges of the courts of appeals, judges of the district courts, and judges of the Court of International Trade. The bill also requires court proceedings to be recorded and published on the internet.

Actions Timeline

- **Nov 1, 2022:** Referred to the Subcommittee on Courts, Intellectual Property, and the Internet.
- **Apr 6, 2022:** Introduced in House
- **Apr 6, 2022:** Referred to the Committee on the Judiciary, and in addition to the Committees on Oversight and Reform, and House Administration, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
