Summary (as of Apr 7, 2022)

Build the Wall Now Act

This bill addresses issues related to the construction of a barrier along the U.S.-Mexico border, such as (1) requiring the Department of Homeland Security to resume any project related to the construction of such a barrier (and any related infrastructure); and (2) exempting such construction projects from various legal requirements, including requirements stemming from the Administrative Procedure Act, the Clean Air Act, and the Clean Water Act.

- **Apr 8, 2022:** Referred to the Subcommittee on Highways and Transit.
- **Apr 8, 2022:** Referred to the Subcommittee on Water Resources and Environment.
- **Apr 7, 2022:** Introduced in House
- **Apr 7, 2022:** Referred to the Committee on Homeland Security, and in addition to the Committees on Natural Resources, Energy and Commerce, Transportation and Infrastructure, Armed Services, Agriculture, Small Business, the Judiciary, and Oversight and Reform, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
