## **Preparing Regulators Effectively for a Post-prohibition Adult-use Regulated Environment Act of 2022 or the PREPARE Act of 2022**

This bill directs the Department of Justice to establish the Commission on the Federal Regulation of Cannabis to study a plausible and prompt pathway to cannabis regulation.

### **Actions Timeline**

- **Nov 1, 2022:** Referred to the Subcommittee on Crime, Terrorism, and Homeland Security.
- **May 5, 2022:** Referred to the Subcommittee on Biotechnology, Horticulture, and Research.
- **Apr 15, 2022:** Referred to the Subcommittee on Health.
- **Apr 14, 2022:** Introduced in House
- **Apr 14, 2022:** Referred to the Committee on Energy and Commerce, and in addition to the Committees on the Judiciary, Ways and Means, Agriculture, and Financial Services, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
