### Farm Credit Administration Independent Authority Act

This bill prohibits the Consumer Financial Protection Bureau from issuing, implementing, or continuing any policy or guidance issued after January 1, 2021, that affects the Farm Credit Administration (FCA), Farm Credit System, or FCA Board.

## Actions Timeline

---

- **Jun 8, 2022:** Referred to the Subcommittee on Commodity Exchanges, Energy, and Credit.
- **May 13, 2022:** Introduced in House
- **May 13, 2022:** Referred to the Committee on Agriculture, and in addition to the Committee on Financial Services, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
