## Summary (as of May 20, 2022)

### Plastic Pellet Free Waters Act

This bill requires the Environmental Protection Agency to issue a final rule that prohibits certain discharges of plastic pellets and other preproduction plastic into waters of the United States.

### Actions Timeline

- **May 23, 2022:** Referred to the Subcommittee on Water Resources and Environment.
- **May 20, 2022:** Introduced in House
- **May 20, 2022:** Referred to the House Committee on Transportation and Infrastructure.
