School Resource Officer Assessment Act of 2022

This bill requires the Department of Justice and the Department of Education to conduct and submit to Congress a survey of the assignment of school resource officers at public elementary and secondary schools.

Actions Timeline

- **Nov 1, 2022:** Referred to the Subcommittee on Crime, Terrorism, and Homeland Security.
- **May 27, 2022:** Introduced in House
- **May 27, 2022:** Referred to the Committee on Education and Labor, and in addition to the Committee on the Judiciary, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
