Summary (as of May 27, 2022)

Multiple Firearm Sales Reporting Modernization Act of 2022

This bill expands reporting requirements with respect to sales or dispositions of multiple firearms.

Currently, a federal firearms licensee (e.g., a gun dealer) must report multiple sales or dispositions of pistols or revolvers to the same person within five business days. This bill requires a federal firearms licensee to report multiple sales or dispositions of any firearms to the same person within five business days.

Actions Timeline

- **Nov 1, 2022:** Referred to the Subcommittee on Crime, Terrorism, and Homeland Security.
- **May 27, 2022:** Introduced in House
- **May 27, 2022:** Referred to the House Committee on the Judiciary.
