Biometric Verification for Entry and Reconfirming Identity with Forensics Act of 2022 or the B-VERIFY Act of 2022

This bill addresses various issues pertaining to immigration, such as (1) requiring any applicant for an immigration benefit, including a U.S. national applying for a noncitizen beneficiary, to provide biometric information, including DNA; (2) permanently barring a noncitizen from becoming a U.S. citizen if the noncitizen is the parent of an unaccompanied alien child who arrives at the U.S. border; and (3) prohibiting the Department of Health and Human Services from expending government funds to provide counsel to detained unaccompanied alien children in legal proceedings.

Actions Timeline

- **Nov 1, 2022:** Referred to the Subcommittee on Immigration and Citizenship.
- **Jun 9, 2022:** Referred to the Subcommittee on Border Security, Facilitation, and Operations.
- **Jun 9, 2022:** Referred to the Subcommittee on Oversight, Management, and Accountability.
- **Jun 8, 2022:** Introduced in House
- **Jun 8, 2022:** Referred to the Committee on the Judiciary, and in addition to the Committee on Homeland Security, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
