Actions Timeline

- **Jun 8, 2022:** Introduced in House
- **Jun 8, 2022:** Referred to the Committee on House Administration, and in addition to the Committees on the Judiciary, Oversight and Reform, and Science, Space, and Technology, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
