## Fighting Foreign Influence Act

This bill addresses foreign influence in federal elections.

For example, the bill (1) requires tax-exempt charitable organizations to disclose in annual reports contributions and gifts exceeding \$50,000 received from foreign governments and foreign political parties; and (2) prohibits any individual from registering or otherwise serving as the agent of a foreign principal if the individual at any time served as a Member of Congress, a senior political appointee, or a general or flag officer of the Armed Forces.

## Actions Timeline

---

- **Nov 1, 2022:** Referred to the Subcommittee on the Constitution, Civil Rights, and Civil Liberties.
- **Jun 16, 2022:** Introduced in House
- **Jun 16, 2022:** Referred to the Committee on House Administration, and in addition to the Committees on Ways and Means, and the Judiciary, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
