Tribal Cultural Areas Protection Act

This bill provides for the preservation of tribal cultural sites on public land, including by establishing the Tribal Cultural Areas System, setting forth requirements related to land management, and authorizing certain actions by tribes.

Actions Timeline

- **Jun 21, 2022:** Referred to the Subcommittee for Indigenous Peoples of the United States.

- **Jun 21, 2022:** Referred to the Subcommittee on Water, Oceans, and Wildlife.
- **Jun 16, 2022:** Introduced in House
- **Jun 16, 2022:** Referred to the Committee on Natural Resources, and in addition to the Committee on Agriculture, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
