## Summary (as of Jun 22, 2022)

### RETURN (Repealing Excise Tax on Unalienable Rights Now) our Constitutional Rights Act of 2022 or the RETURN our Constitutional Rights Act of 2022

This bill repeals the excise taxes on firearms and ammunition and on bows and arrows. It also repeals the excise tax on transferring and making firearms under the National Firearm Act.

## Actions Timeline

- **Jul 19, 2022:** Sponsor introductory remarks on measure. (CR H6869)
- **Jun 22, 2022:** Introduced in House
- **Jun 22, 2022:** Referred to the Committee on Ways and Means, and in addition to the Committee on Natural Resources, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
