Border's Unused Idle and Lying Dormant Inventory Transfer Act or the BUILD IT Act

This bill requires the federal government to transfer, upon request, materials associated with the construction of a barrier along the U.S.-Mexico border to the governments of the states along that border (i.e., Arizona, California, New Mexico, and Texas). The transferred materials must be used to construct a barrier along the U.S.-Mexico border.

Actions Timeline

- **Jun 25, 2022:** Referred to the Subcommittee on Oversight, Management, and Accountability.
- **Jun 25, 2022:** Referred to the Subcommittee on Border Security, Facilitation, and Operations.
- **Jun 24, 2022:** Introduced in House
- **Jun 24, 2022:** Referred to the Committee on Oversight and Reform, and in addition to the Committees on Homeland Security, and Armed Services, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
