Transportation, Housing and Urban Development, Agriculture, Rural Development, Energy and Water Development, Financial Services and General Government, Interior, Environment, Military Construction, and Veterans Affairs Appropriations Act, 2023

This bill provides FY2023 appropriations for several federal departments and agencies.

It includes 6 of the 12 regular FY2023 appropriations bills:

- the Transportation, Housing and Urban Development, and Related Agencies Appropriations Act, 2023;
- the Agriculture, Rural Development, Food and Drug Administration, and Related Agencies Appropriations Act, 2023;
- the Energy and Water Development and Related Agencies Appropriations Act, 2023;
- the Financial Services and General Government Appropriations Act, 2023;
- the Department of the Interior, Environment, and Related Agencies Appropriations Act, 2023; and
- the Military Construction, Veterans Affairs, and Related Agencies Appropriations Act, 2023.

The departments, agencies, and activities funded in the bill include

- the Department of Transportation,
- the Department of Housing and Urban Development,
- the Department of Agriculture,
- the Food and Drug Administration,
- the Commodity Futures Trading Commission,
- the civil works projects of the U.S. Army Corps of Engineers,
- the Department of Energy,
- the Bureau of Reclamation,
- the Department of the Treasury,
- the Executive Office of the President,
- the judiciary,
- the District of Columbia,
- the Department of the Interior,
- the Environmental Protection Agency,
- the Forest Service,
- Department of Defense military construction and family housing activities,
- the Department of Veterans Affairs, and
- several related and independent agencies.

The bill also specifies restrictions and requirements for using funds provided by this and other appropriations acts.

- **Jul 19, 2022:** Rules Committee Resolution H. Res. 1232 Reported to House. Rule provides for consideration of H.R. 8294, H.R. 8373 and H.R. 8404. Provides for one of hour of general debate on each bill as well as one motion to recommit. Amendments are made in order. Resolution also provides for en bloc suspension authority. H. Res. 1230 is considered adopted.
- **Jul 19, 2022:** Considered under the provisions of rule H. Res. 1232. (consideration: CR H6741-6859; text: CR H6741-6836)
- **Jul 19, 2022:** Rule provides for consideration of H.R. 8294, H.R. 8373 and H.R. 8404. Provides for one of hour of general debate on each bill as well as one motion to recommit. Amendments are made in order. Resolution also provides for en bloc suspension authority. H. Res. 1230 is considered adopted.
- **Jul 19, 2022:** The Speaker designated the Honorable Kathy E. Manning to act as Chairwoman of the Committee.
- **Jul 19, 2022:** House resolved itself into the Committee of the Whole House on the state of the Union pursuant to H. Res. 1232 and Rule XVIII.
