### Summary (as of Jul 19, 2022)

#### Allowing Greater Access to Safe and Effective Contraception Act

This bill requires the Food and Drug Administration to prioritize review of supplemental applications for over-the-counter oral contraceptives that are intended for routine use. It also removes certain limitations in relation to such products and health savings accounts, flexible spending arrangements, and other arrangements (e.g., limitations on the number of items that may be purchased).

### Actions Timeline

- **Jul 19, 2022:** Introduced in House
- **Jul 19, 2022:** Referred to the Committee on Ways and Means, and in addition to the Committee on Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Jul 19, 2022:** Referred to the Subcommittee on Health.
