Sets forth the rule for consideration of the (H.R. 5665) to establish in the Department of State the Office to Monitor and Combat Islamophobia.

Actions Timeline

- **Dec 14, 2021:** Introduced in House
- **Dec 14, 2021:** The House Committee on Rules reported an original measure, H. Rept. 117-218, by Mr. McGovern.
- **Dec 14, 2021:** Rule provides for consideration of H.R. 5665 with 1 hour of general debate. Previous question shall be considered as ordered without intervening motions except motion to recommit. Measure will be considered read. Bill is closed to amendments.
- **Dec 14, 2021:** Placed on the House Calendar, Calendar No. 58.
- **Dec 14, 2021:** Considered as privileged matter. (consideration: CR H7653-7665)
- **Dec 14, 2021:** DEBATE - The House proceeded with one hour of debate on H. Res. 849.
- **Dec 14, 2021:** POSTPONED PROCEEDINGS - At the conclusion of debate on H. Res. 849, the Chair put the question on ordering the previous question and by voice vote announced that the yeas had prevailed. Mr. Reschenthaler demanded the yeas and nays and the Chair postponed further proceedings on ordering the previous question until a time to be announced.
- **Dec 14, 2021:** Considered as unfinished business. (consideration: CR H7665-7666)
- **Dec 14, 2021:** On ordering the previous question Agreed to by the Yeas and Nays: 220 - 210 (Roll no. 443).
