Providing for consideration of the bill (H.R. 447) to amend the Act of August 16, 1937 (commonly referred to as the "National Apprenticeship Act") and expand the national apprenticeship system to include apprenticeships, youth apprenticeships, and pre-apprenticeship registered under such Act, to promote the furtherance of labor standards necessary to safeguard the welfare of apprentices, and for other purposes; providing for consideration of the concurrent resolution (H. Sets forth the rule for consideration of the bill (H.R. 447) to amend the Act of August 16, 1937 (commonly referred to as the "National Apprenticeship Act") and expand the national apprenticeship system to include apprenticeships, youth apprenticeships, and pre-apprenticeship registered under such Act, to promote the furtherance of labor standards necessary to safeguard the welfare of apprentices, and for other purposes; providing for consideration of the concurrent resolution (H. Con. Res. 11) establishing the congressional budget for the United States Government for fiscal year 2021 and setting forth the appropriate budgetary levels for fiscal years 2022 through 2030.

## **Actions Timeline**

- **Feb 2, 2021:** Introduced in House
- **Feb 2, 2021:** The House Committee on Rules reported an original measure, H. Rept. 117-3, by Mr. Morelle.
- **Feb 2, 2021:** Rule provides for consideration of H.R. 447 and H. Con. Res. 11 with 1 hour of debate on H.R. 447 and 3 hours of debate on H. Con. Res. 11. The previous question on both measures shall be considered as ordered. The rule also provides for a motion to recommit on H.R. 447.
- **Feb 2, 2021:** Placed on the House Calendar, Calendar No. 3.
- **Feb 2, 2021:** Considered as privileged matter. (consideration: CR H266-273)
- **Feb 2, 2021:** DEBATE - The House proceeded with one hour of debate on H. Res. 85.
- **Feb 2, 2021:** POSTPONED PROCEEDINGS - At the conclusion of debate on H. Res. 85, the Chair put the question on ordering the previous question and by voice vote, announced that the ayes had prevailed. Mr. Burgess demanded the yeas and nays and the Chair postponed further proceedings on ordering the previous question until a time to be announced.
- **Feb 2, 2021:** Considered as unfinished business. (consideration: CR H273-274)
- **Feb 2, 2021:** On ordering the previous question Agreed to by the Yeas and Nays: 219 - 207 (Roll no. 19).
- **Feb 2, 2021:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 216 - 210 (Roll no. 20). (text: CR H266)
- **Feb 2, 2021:** On agreeing to the resolution Agreed to by the Yeas and Nays: 216 - 210 (Roll no. 20). (text: CR H266)
