Summary (as of Dec 14, 2021)

This resolution finds Mark Meadows in contempt of Congress for failure to comply with a congressional subpoena. The resolution further requires the Speaker of the House to certify the matter for prosecution and to take all appropriate action to enforce the subpoena.

Actions Timeline

- **Dec 14, 2021:** Introduced in House
- **Dec 14, 2021:** By direction of the Select Committee to Investigate the January 6th Attack on the United States Capitol, Mr. Thompson (MS) called up H. Res. 851 and asked for its immediate consideration.
- **Dec 14, 2021:** Considered under the provisions of rule H. Res. 848. (consideration: CR H7667-7794)
- **Dec 14, 2021:** Previous question shall be considered as ordered without intervening motions. Providing for consideration relating to a resolution to accompany House Report 117-216.
- **Dec 14, 2021:** DEBATE - The House proceeded with one hour of debate on H. Res. 851.
- **Dec 14, 2021:** WORDS TAKEN DOWN - During the course of debate, exception was taken to certain words used and a demand was made to have the words taken down. After review, the Chair ruled that the words were not violation of the spirit of debate.
- **Dec 14, 2021:** DEBATE - The House continued with further debate on H. Res. 851.
- **Dec 14, 2021:** The previous question was ordered pursuant to the rule.
- **Dec 14, 2021:** POSTPONED PROCEEDINGS - At the conclusion of debate on H. Res. 851, the Chair put the question on agreeing to the resolution, and by voice vote, announced that the ayes had prevailed. Mr. Banks demanded the yeas and nays and further proceedings on agreeing to the resolution were postponed until a time to be announced.
- **Dec 14, 2021:** Considered as unfinished business. (consideration: CR H7814-7815)
- **Dec 14, 2021:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 222 - 208 (Roll no. 447).(text: CR H7785)
- **Dec 14, 2021:** On agreeing to the resolution Agreed to by the Yeas and Nays: 222 - 208 (Roll no. 447). (text: CR H7785)
