Summary (as of Jul 27, 2022)

Deter PRC Support to the Russian War Effort Act

The bill authorizes the President to impose sanctions on persons associated with China for financial, material, or technological support contributing materially to Russia's military action in Ukraine. The sanctions include, for example, blocking transactions in U.S. property and prohibiting U.S. entry visas.

Actions Timeline

- **Nov 1, 2022:** Referred to the Subcommittee on Immigration and Citizenship.
- **Jul 27, 2022:** Introduced in House
- **Jul 27, 2022:** Referred to the Committee on Foreign Affairs, and in addition to the Committees on the Judiciary, Financial Services, Ways and Means, and Intelligence (Permanent Select), for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
