Supporting Medicare Providers Act of 2022

This bill extends a payment increase under Medicare's physician fee schedule through the end of 2023 (currently set to expire at the end of 2022).

Actions Timeline

- **Sep 14, 2022:** Referred to the Subcommittee on Health.
- **Sep 13, 2022:** Introduced in House
- **Sep 13, 2022:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
