Protect the UNBORN (Undo the Negligent Biden Orders Right Now) Act or the Protect the UNBORN Act

This bill prohibits federal implementation of and funding for specified executive orders that address access to reproductive health care services, including services related to pregnancy or the termination of a pregnancy.

Actions Timeline

- **Sep 16, 2022:** Referred to the Subcommittee on Health.
- **Sep 15, 2022:** Introduced in House
- **Sep 15, 2022:** Referred to the Committee on Energy and Commerce, and in addition to the Committees on the Judiciary, and Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
