## Fairness for 9/11 Families Act

This bill authorizes and provides funding for lump-sum catch-up payments from the United States Victims of State Sponsored Terrorism Fund to 9/11 victims, 9/11 spouses, and 9/11 dependents.

The bill also rescinds specified unobligated funds that were provided to the Small Business Administration for the Paycheck Protection Program.

### Actions Timeline

- **Nov 15, 2022:** Read the second time. Placed on Senate Legislative Calendar under General Orders. Calendar No. 547.
- **Nov 14, 2022:** Read the first time. Placed on Senate Legislative Calendar under Read the First Time.
- **Oct 11, 2022:** Received in the Senate.
- **Sep 30, 2022:** Considered under the provisions of rule H. Res. 1404. (consideration: CR H8351-8354)
- **Sep 30, 2022:** Resolution provides for the consideration of the Senate amendment to H. R. 6833 and H.R. 8987, and an hour of debate for each measure. It also provides for a motion to recommit H.R. 6833.
- **Sep 30, 2022:** DEBATE - The House proceeded with one hour of debate on H.R. 8987.
- **Sep 30, 2022:** The previous question was ordered pursuant to the rule.
- **Sep 30, 2022:** POSTPONED PROCEEDINGS - At the conclusion of debate on H.R. 8987, the Chair put the question on passage of the bill and by voice vote, announced that the ayes had prevailed. Mr. Biggs demanded the yeas and nays and the Chair postponed further proceedings until a time to be announced.
- **Sep 30, 2022:** Considered as unfinished business. (consideration: CR H8355-8356)
- **Sep 30, 2022:** Passed/agreed to in House: On passage Passed by the Yeas and Nays: 400 - 31 (Roll no. 477).
- **Sep 30, 2022:** On passage Passed by the Yeas and Nays: 400 - 31 (Roll no. 477). (text: CR H8351)
- **Sep 30, 2022:** Motion to reconsider laid on the table Agreed to without objection.
- **Sep 26, 2022:** Introduced in House
- **Sep 26, 2022:** Referred to the Committee on the Judiciary, and in addition to the Committees on the Budget, and Appropriations, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
