Sets forth the rule for consideration of the bill (H.R. 3485) to impose sanctions on foreign persons responsible for violations of internationally recognized human rights against lesbian, gay, bisexual, transgender, queer and intersex (LGBTQI) individuals, and for other purposes; providing for consideration of the bill (H.R. 4445) to amend title 9 of the United States Code with respect to arbitration of disputes involving sexual assault and sexual harassment; providing for consideration of the bill (H.R. 4521) to provide for a coordinated Federal research initiative to ensure continued United States leadership in engineering biology.

Actions Timeline

- **Feb 2, 2022:** Introduced in House
- **Feb 2, 2022:** The House Committee on Rules reported an original measure, H. Rept. 117-241, by Ms. Ross.
- **Feb 2, 2022:** The rule provides for one hour of general debate on H.R. 3485 and H.R. 4445. The rule provides for two hours of general debate on H.R. 4521. The resolution provides for one motion to recommit for all three bills. The resolution amends H. Res. 188 by striking February 4, 2022 and inserting April 1, 2022. Also, the resolution provides that proceedings may be postponed through March 3, 2022 on measures that were the object of motions to suspend the rules on the legislative day of February 1, 2022, and on which the yeas and nays were ordered.
- **Feb 2, 2022:** Placed on the House Calendar, Calendar No. 63.
- **Feb 2, 2022:** Considered as privileged matter. (consideration: CR H348-357)
- **Feb 2, 2022:** DEBATE - The House proceeded with one hour of debate on H. Res. 900.
- **Feb 2, 2022:** On ordering the previous question Agreed to by the Yeas and Nays: 219 - 205 (Roll no. 16). (consideration: CR H356-357)
- **Feb 2, 2022:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 219 - 203 (Roll no. 17). (text: CR H348-349)
- **Feb 2, 2022:** On agreeing to the resolution Agreed to by the Yeas and Nays: 219 - 203 (Roll no. 17). (text: CR H348-349)
