Summary (as of Oct 25, 2022)

Trust in Government Act of 2022

This bill directs certain agencies (e.g., the Department of State, the Department of Veterans Affairs, and the Social Security Administration) to take specified steps to improve service delivery and public perception of agency interactions.

The Office of Management and Budget must designate a team of individuals to lead and support agency initiatives to improve public perception of agency interactions.

Actions Timeline

- **Oct 26, 2022:** Referred to the Subcommittee on Health.
- **Oct 25, 2022:** Introduced in House
- **Oct 25, 2022:** Referred to the Committee on Oversight and Reform, and in addition to the Committees on Foreign Affairs, Ways and Means, Natural Resources, Agriculture, Energy and Commerce, Education and Labor, Veterans' Affairs, Homeland Security, Small Business, and Armed Services, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Oct 25, 2022:** Referred to the Subcommittee on Transportation and Maritime Security.
