Summary (as of Dec 1, 2022)

Protecting Communities from Plastics Act

This bill sets forth a variety of requirements and incentives to reduce the production and use of plastics and other petrochemicals, including by directing the Environmental Protection Agency to place a temporary pause on certain new permits for petrochemical facilities under the Clean Air Act and the Clean Water Act.

Actions Timeline

- **Dec 2, 2022:** Referred to the Subcommittee on Water Resources and Environment.
- **Dec 1, 2022:** Introduced in House
- **Dec 1, 2022:** Referred to the Committee on Energy and Commerce, and in addition to the Committees on Transportation and Infrastructure, Agriculture, and Foreign Affairs, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
