### Summary (as of Mar 22, 2024)

This concurrent resolution recognizes that people with disabilities experience barriers to access every day and pledges to make universal and inclusive design a guiding principle for all infrastructure bills and projects.

### **Actions Timeline**

- Mar 29, 2024: Referred to the Subcommittee on Health.
- Mar 22, 2024: Introduced in House
- Mar 22, 2024: Referred to the Committee on Education and the Workforce, and in addition to the Committees on the Judiciary, Transportation and Infrastructure, Energy and Commerce, and Oversight and Accountability, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
