## Summary (as of Mar 13, 2024)

This resolution condemns Russia's nuclear escalatory rhetoric and implied threats on the potential use of nuclear weapons to further its invasion of Ukraine. The resolution also (1) condemns Russia's purported suspension of participation in the New START Treaty, (2) emphasizes the value of arms control agreements between the United States and Russia, and (3) calls on the Biden administration to continue pursuing nuclear arms control and risk reduction with Russia and China.
