## Summary (as of Feb 24, 2023)

### Taiwan International Solidarity Act

This bill requires the Department of State to annually report to Congress on efforts by China to undermine Taiwan's participation in international organizations or Taiwan's relationships with other countries.

### Actions Timeline

- **Jul 26, 2023:** Received in the Senate and Read twice and referred to the Committee on Foreign Relations.
- **Jul 25, 2023:** Mr. Barr moved to suspend the rules and pass the bill.
- **Jul 25, 2023:** Considered under suspension of the rules. (consideration: CR H3913-3915)
- **Jul 25, 2023:** DEBATE - The House proceeded with forty minutes of debate on H.R. 1176.
- **Jul 25, 2023:** Passed/agreed to in House: On motion to suspend the rules and pass the bill Agreed to by voice vote. (text: CR H3913)
