### Summary (as of Jun 3, 2024)

This resolution calls on elected officials, faith leaders, and civil society leaders to condemn and counter antisemitism.

The resolution also (1) urges that all possible steps be taken to ensure the safety and security of Jewish American communities, and (2) calls on the Executive Branch and civic leaders to identify and educate the public on the contributions of the Jewish American community.

### Actions Timeline

- **Jun 3, 2024:** Mr. Jordan moved to suspend the rules and agree to the resolution, as amended.
- **Jun 3, 2024:** Considered under suspension of the rules. (consideration: CR H3549-3551)
- **Jun 3, 2024:** DEBATE - The House proceeded with forty minutes of debate on H. Res. 1215.
- **Jun 3, 2024:** At the conclusion of debate, the Yeas and Nays were demanded and ordered. Pursuant to the provisions of clause 8, rule XX, the Chair announced that further proceedings on the motion would be postponed.
- **Jun 3, 2024:** Considered as unfinished business. (consideration: CR H3567-3568)
- **Jun 3, 2024:** Passed/agreed to in House: On motion to suspend the rules and agree to the resolution, as amended Agreed to by the Yeas and Nays: (2/3 required): 371 - 0 (Roll no. 233). (text: CR H3549)
