Summary (as of Feb 14, 2023)

This resolution expresses the sense of the House of Representatives that it is necessary to expand the use of nuclear energy in order to (1) meet the growing energy demands of the United States, and (2) promote American nuclear energy leadership while retaining U.S. economic viability in the worldwide nuclear energy marketplace.

Actions Timeline

- **Feb 24, 2023:** Referred to the Subcommittee on Energy, Climate and Grid Security.
- **Feb 14, 2023:** Introduced in House
- **Feb 14, 2023:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Armed Services, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
