Summary (as of Jun 12, 2024)

This resolution finds Attorney General Merrick Brian Garland in contempt of Congress for failing to comply with a congressional subpoena. It also directs the Speaker of the House to (1) certify the related report from the House Judiciary Committee to the United States Attorney's Office for the District of Columbia for criminal proceedings, and (2) take all other appropriate action to enforce the subpoena.

Actions Timeline

- **Jun 12, 2024:** Introduced in House
- **Jun 12, 2024:** By direction of the Committee on the Judiciary, Mr. Jordan called up H. Res. 1292 and asked for its immediate consideration.
- **Jun 12, 2024:** Considered under the provisions of rule H. Res. 1287. (consideration: CR H3759-3767)
- **Jun 12, 2024:** Rule provides for consideration of H.R. 8070. The resolution provides for consideration of H.R. 8070 under a structured rule and the resolution accompanying House Report 118-527 under a closed rule. The resolution provides for one hour of general debate on each measure and one motion to recommit on H.R. 8070.
- **Jun 12, 2024:** DEBATE - The House proceeded with one hour of debate on H. Res. 1292.
- **Jun 12, 2024:** The previous question was ordered pursuant to the rule.
- **Jun 12, 2024:** POSTPONED PROCEEDINGS - Pursuant to clause 1(c) of rule XIX, the Chair announced further proceedings on H. Res. 1292 would be postponed.
- **Jun 12, 2024:** Pursuant to clause 1(c) of rule XIX, further proceedings resumed on H.Res. 1292.
- **Jun 12, 2024:** Considered as unfinished business. (consideration: CR H3970-3971)
- **Jun 12, 2024:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 216 - 207 (Roll no. 260). (text: CR H3759)
