Summary (as of Feb 27, 2023)

This resolution mourns the loss of life in Turkey (Turkiye) and Syria caused by the earthquakes in Turkey on February 6, 2023. The resolution also (1) applauds the work of humanitarian aid and rescue workers on the ground; and (2) condemns the efforts by the Assad regime of Syria to exploit the disaster to evade international pressure and accountability, including by preventing the United Nations from providing assistance through border crossings between Turkey and Syria.

Actions Timeline

- **Feb 27, 2023:** Mr. Wilson (SC) moved to suspend the rules and agree to the resolution.
- **Feb 27, 2023:** Considered under suspension of the rules. (consideration: CR H886-890, H896-897)
- **Feb 27, 2023:** DEBATE - The House proceeded with forty minutes of debate on H. Res. 132.
- **Feb 27, 2023:** At the conclusion of debate, the Yeas and Nays were demanded and ordered. Pursuant to the provisions of clause 8, rule XX, the Chair announced that further proceedings on the motion would be postponed.
