Summary (as of Mar 7, 2023)

Eradicating Narcotic Drugs and Formulating Effective New Tools to Address National Yearly Losses of life Act or the END FENTANYL Act

This bill requires U.S. Customs and Border Protection to review and update, as necessary, manuals and policies related to inspections at ports of entry to ensure the uniformity of inspection practices to effectively detect illegal activity along the border, such as the smuggling of drugs and humans.

Actions Timeline

- **Dec 17, 2024:** Referred to the Subcommittee on Trade.
- **Mar 8, 2023:** Referred to the Subcommittee on Border Security and Enforcement.
- **Mar 7, 2023:** Introduced in House
- **Mar 7, 2023:** Referred to the Committee on Homeland Security, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
