Summary (as of Nov 20, 2024)

This resolution condemns the rise of antisemitism around the world and encourages greater international cooperation to counter antisemitism. The resolution also welcomes the Global Guidelines for Countering Antisemitism (an international framework launched in July 2024 that includes policies to monitor and combat antisemitism) and calls upon states and international bodies to embrace these guidelines.

Actions Timeline

- Nov 20, 2024: Mr. Moylan moved to suspend the rules and agree to the resolution.
- Nov 20, 2024: Considered under suspension of the rules. (consideration: CR H6133-6135)
- Nov 20, 2024: DEBATE - The House proceeded with forty minutes of debate on H. Res. 1449.
