## Summary (as of Jan 12, 2023)

This joint resolution nullifies the Local Resident Voting Rights Amendment Act of 2022, enacted by the council of the District of Columbia on October 18, 2022. The act allows noncitizens who meet residency and other requirements to vote in local elections in the district.
