### Summary (as of May 11, 2023)

This joint resolution nullifies the final rule issued by the National Marine Fisheries Service titled *Endangered and Threatened Wildlife and Plants; Regulations for Listing Endangered and Threatened Species and Designating Critical Habitat* and published on June 24, 2022.

The 2022 rule rescinds an earlier rule which limited the ability of the service to designate an area a *critical habitat*. Areas designated as *critical habitat* are subject to certain statutory restrictions.
