Preparing Regulators Effectively for a Post-prohibition Adult-use Regulated Environment Act of 2023 or the PREPARE Act of 2023

This bill directs the Department of Justice to establish the Commission on the Federal Regulation of Cannabis to study a plausible and prompt pathway to cannabis regulation.

- **Apr 21, 2023:** Referred to the Subcommittee on Health.
- **Apr 13, 2023:** Introduced in House
- **Apr 13, 2023:** Referred to the Committee on Energy and Commerce, and in addition to the Committees on the Judiciary, Ways and Means, Agriculture, and Financial Services, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
